- Candidates allotted seat through NCHM JEE should make rest of the fee of first semester to the allotted Institute excluding the Seat Acceptance Fee of Rs. 20,000.
- There is no concession in fee for Reserved Category students. However, they may avail the Scholarship from respective Government/Scholarship granting authority.

1. Since, the NEP will start from 2023-24 academic year, those who will opt for four years degree, for them, the fee fc 4th Year will be as same as prescribed for 3 rd Year +NCHM Enrolment Fee Rs. 1000/-.
