Full time Bachelor's Degree or Diploma of minimum 3-years duration for which minimum pre-requisite qualification is 12th as framed by regulator/ university in Hospitality / Hotel Administration / Hotel Management/ Culinary Art from a recognized University/ Institute securing not less than 55% marks in aggregate and at least 2 years of hospitality industry experience and also **should have qualified NHTET with prescribed percentage**, **conducted by NCHMCT**.

Those having Ph.D degree in hospitality related subject from a recognized University / Institute after above prescribed qualification, need not to qualify NHTET.
